

ASPA Report ‘The State of Counterfeiting in India 2021’



Authentication Solution Providers’ Association (ASPA) has released the latest edition of its report ‘The State of Counterfeiting in India – 2021’ which highlights the trends of counterfeiting incidents reported in India for the period January 2018 to December 2020, with special emphasis on cases reported in the year 2020.

According to this report, counterfeiting costs the Indian economy INR 1 trillion every year. “In fact, one in three Indian adults have been victims of fake products from one or the other e-commerce websites, making online counterfeiting the fastest growing crime,” notes the report.


Key Findings

- Counterfeit incidents increased by average 20% in the last three years (between 2018-20). In 2020, 666 cases were reported with an increase of 96 cases compared to 2019 (570).
- Most vulnerable industries and products, needing special attention are Alcohol, Tobacco, FMCG Packaged Goods, Currency and Pharmaceuticals. These five industries constituted more than 84 percent of reported counterfeit incidents.

- Uttar Pradesh, Rajasthan, Madhya Pradesh, Jharkhand, Haryana, Bihar, Punjab, West Bengal, Maharashtra, Odisha, Delhi, Chhattisgarh and Karnataka are the top ten States in terms of number of counterfeiting incidents reported.

- Tobacco faced the highest jump in 2020 over 2019 and 2018. According to a query response raised in the Lok Sabha, Indian authorities seized illegally imported cigarettes worth INR 1,772 crore between April 2020 and February 2021. That compares with seizures worth INR 187.6 crore in the previous financial year.



Reasons for Rise in Counterfeiting

- ❑ **No specific legislation to address counterfeiting:** India has a robust legal framework for combating counterfeiting and piracy, but a lot still needs to be done to simplify the enforcement procedure (as there is no specific legislation to address it).
- ❑ **Challenges in enforcement and execution:** Although a small number of India's state authorities, including Maharashtra and Telangana, continue to operate dedicated crime enforcement units, other States have not followed suit or face organizational challenges. Further, slow execution encourages the criminals to continue their fraudster activities.
- ❑ **Non-adoption of technologies leading to Identification:** Many times, in absence of anti-counterfeiting technologies, it becomes difficult for the Police and the Enforcement & Investigative officers to identify the difference between genuine vs. fake, which further results in weak FIR and loopholes in evidence.
- ❑ **Need clarity on regulations:** Pharmaceuticals, Tobacco and Alcohol: The brand owners need to be more aware.
