
## SHARP GROWTH IN ILLEGAL CIGARETTE TRADE IN INDIA DUE TO EXCESSIVE TAXATION AND EXTREME REGULATIONS ON CIGARETTES


- High Cigarette taxation and extreme tobacco control regulations such as the 85% Pictorial Warning on Tobacco Product Packs in India have led to the decline of Legal Cigarettes in the country while Illegal Cigarette Trade has grown significantly.
- High taxation on Cigarettes and extreme regulations have been counterproductive. They do not reduce demand, but merely shift the demand from the Legal tax-paid and regulation-compliant products to Illegal tax-evaded and non-compliant products.
- According to a study by IMRB (Indian Market Research Bureau), since the implementation of the 85% Pictorial Warning in India in April 2016, consumers have demonstrated a noticeable preference for smuggled cigarettes without the specified warnings.
- International cigarette brands are globally recognized and appeal to consumers across the world including in India. These cigarettes smuggled into India do not carry the mandated pictorial warnings. Absence of the mandated warnings creates an impression amongst the consumers that they are safer than the legal cigarettes which bear the mandated warnings.
- High taxation on cigarettes over the years has impacted the legal cigarette industry and provided a huge fillip to the illegal cigarette trade in the country.
- Cigarette taxes in India (as a percentage of per capita GDP) are almost 17 times higher than in the USA; 10 times higher than Japan; 7 times more than China and Germany; 6 times higher than Canada and Russia; 4 times more than Thailand & Malaysia and 3 times higher than Pakistan & UK.

• Excessive taxation has made Legal Cigarettes in India amongst the least affordable in the world (as per WHO Report 2021<sup>1</sup>). This has fuelled the growth of illicit cigarette trade in the country.

- Illegal cigarettes are sold at very low prices due to tax evasion, which provides huge arbitrage opportunities.
- According to Euromonitor International, illegal cigarette volumes in India is estimated at 26.8 billion sticks in 2021, making India the 4<sup>th</sup> largest illicit cigarette market in the world.
- With shrinking legal cigarette volume, illicit cigarettes are now 1/3<sup>rd</sup> of the legal cigarette volume.



- Media reports indicate illicit Source: Euromonitor International, 2022 cigarettes are being seized across the country almost on a daily basis.
- Only a single enforcement agency, viz. Directorate of Revenue Intelligence (DRI) has seized 14 crore smuggled cigarettes in 2021-22, according to a Lok Sabha statement by the Ministry of Finance in March 2022.
- The reported seizures are only the tip of the gigantic iceberg of a much larger operation, as for every seizure multiple consignments escape surveillance. This is evidenced by the widespread availability and universal presence of smuggled cigarettes across markets.
- The smuggled trade in cigarettes in India, like rest of the world, is controlled by organized criminal syndicates and terror groups, both enemies of our country.
- Acknowledging the serious threat posed by illicit cigarette trade, the Head of the WHO FCTC Secretariat, Dr. Adriana Blanco Marquizo, stated that illicit cigarette trade "....causes substantial losses in government revenues, and at the same time contributes to the funding of international criminal activities."
- Growth in illegal cigarette trade has many undesirable consequences:
  - Causes revenue loss of more than Rs. 15,500 crores per annum to the Exchequer, as per a recent FICCI-CASCADE study
  - Increases the affordability and accessibility of tobacco products
  - Benefits organized criminal syndicates and terror outfits who control this illegal activity
  - Adversely impacts the earnings of domestic tobacco farmers as contraband cigarettes do not use domestic tobaccos
  - Undermines the objectives of tobacco control by not adhering to tobacco regulations
